Public Library Trustees: Making a difference in BC's communities 1 hour at a time This campaign was inspired by, and with approval borrowed from, the LGMA campaign "100,000 Hours". Throughout 2020 we are asking trustees to track their volunteer hours and to record those hours through the BCLTA website. The recorded hours will be part of the story of how BC public library trustees give to their communities as volunteers. We want to share the value and importance of trustee volunteer work. We want others to know, particularly the provincial government, how public library trustees build BC communities one volunteer hour at a time.

At the end of 2020 a BCLTA report, informed by this campaign, will be made publicly available and will be delivered to the provincial government with our ongoing message that trustees are community builders who make a difference to community well-being and resiliency across BC. This report will support BCLTA's continued request that the Ministry of Education, in their responsibility for the Library Act, fund public library board and trustee governance development.

## Updates and New Resources

The BCLTA website has details about the new BCLTA Governance Workshops, an updated for 2020 and downloadable Governance Workbook, and the new BC Public Library Governance: A quick guide for trustees.

BCLTA Re-organization BCLTA has posted the position of Executive Director and has begun receiving applications. The BCLTA is looking for an ED with not-for-profit senior management experience, a demonstrated skill in fund development, and a high level of political and business acumen.

This re-organization will happen with the current budget for BCLTA staffing contracts. Jan Thomas will continue as the Bookkeeper and Babs Kelly will move into her new role as Director for

Communications and Engagement. Babs will focus on delivering value to the membership through services such as the website, the Bulletin, governance resources, workshops and other board and trustee development initiatives.

# Representing

As shared in the January 24th, BC Public Library Partners update, the Partners are preparing for the BC provincial budget lock-up, happening Tuesday, February 18th in Victoria. The Partners will share the budget news and our shared response as soon as is possible after the lock-up. The Partners are making a final push on the \$20M in 2020 campaign, meeting with key MLAs and sharing through our networks and communication channels, including social media accounts, good news stories about how public libraries support provincial goals.

The BCLTA invited Minister Fleming to the Forum to meet with trustees and to learn more about the responsibilities and impact of public library board work. The Minister declined due to a scheduling conflict, but we are hoping that ADM McCrea will attend. ADM McCrea joined the BCLTA directors at their board retreat this past September and she expressed an interest in learning more about public library governance. We have encouraged her to attend the Forum as a unique opportunity to meet with trustees and library directors from across the province.

As reported last month, BCLTA will continue to communicate the value of public library boards to the Ministry of Education. We have reissued our invitation to the Minister and the ministry to meet with the BCLTA and to participate in a brief public library governance workshop so that they might better understand the role of trustees and the governance of BC public libraries.

At their February board meeting the BCLTA board approved the wording of a statement that proposes a shared BCLTA and Ministry commitment to the ongoing support of public library board excellence across BC. The BCLTA will be asking the Ministry to meet with us to discuss and to adopt this shared commitment statement that outlines the role of the Ministry's responsibilities for the Library Act and BCLTA's responsibilities to the membership for governance support and development.

As BC's professional association for public library boards and trustees we rely on our members to inform our services and the overall strategic direction of the BCLTA.
